



## **Anne Look Education Scholarship Criteria**

### **Dickinson Area Community Foundation**

*Four scholarships will be awarded. One recipient will be chosen from each of the following schools: Iron Mountain, Kingsford, North Dickinson, and Norway High Schools. The recipients shall receive a renewable scholarship award in an amount to be determined annually based upon the earned income of the fund.*

#### **Eligibility:**

1. The recipient must be a graduating Iron Mountain, Kingsford, North Dickinson, or Norway High School Senior.
2. The applicant may be enrolling in either a 2-year (Associate) or 4-year degree curriculum and pursuing a career in Early Childhood Education. If no recipients in this field are forthcoming, then careers in General Education (teaching) will be considered.
3. The applicant must have a GPA of 2.75 GPA or higher.
4. A transcript of the student's high school records must be supplied.
5. Applicants must submit a character reference letter from a teacher and one from a person who is familiar with the student (cannot be a family member).
6. The applicant must write a paragraph stating how their field of study applies to the Early Childhood Education or General Education (teaching) profession.
7. All completed applications must be returned to the Guidance Office by **March 15<sup>th</sup>**. Failure to turn in a completed application by this date will result in the student being ineligible to apply for this scholarship.
8. The Scholarship Selection Advisory Committee shall consider financial need as well as academic performance and extracurricular activities as the Scholarship Selection Advisory Committee may determine from time to time.
9. The scholarship shall be a renewable award of four equal payments over a four year period, providing the recipient remains eligible to receive the award. To remain eligible for the renewable award, the recipient must be a full-time student (12 or more credit hours per semester or the equivalent), maintain a minimum GPA of 2.75, and continue to major in Early Childhood or General Education. The recipient must submit their official college transcript to DACF each year to confirm eligibility prior to award disbursement.
10. A scholarship award may be revoked by the DACF Board of Trustees because of:
  - Criminal or anti-social conduct of recipient,
  - Filing false information on application,
  - Scholastic inadequacy of a recipient,
  - For such other good cause as the Board may, in its sole discretion, determine.

Revocation shall be by the action of a majority of the members of the DACF Board of Trustees, and upon such revocation, any and all funds still controlled by the Board of Trustees, shall be withheld and disposed of at the discretion of the Board.
